Gladstone Police Response

The Kansas City Police Department contacted Gladstone 911 dispatch at 03:12 a.m. on the morning of Sept. 19th with information regarding an assault of an AT&T employee in Gladstone. The victim was reported to be in a parking lot in an AT&T utility truck with the orange beacon light on. The location given for the assault was 3133 NE 59th Terrace, which is in the Kendallwood Apartment and Townhome complex. Gladstone officers arrived on scene within two minutes of being dispatched. Officers searched the multiple parking lots of the apartment complex and were unable to locate the described AT&T truck. After an expanded search of the area involving four (4) officers, Mashburn's truck was located in a residential side yard on NE 57th Terrace, which is not in the complex. Officers arrived at Mashburn's locked truck at 03:42 a.m. and began rendering emergency care.

3:34:48 **Gladstone Dispatcher #1:** I have been in contact with their dispatch. Their dispatch has stated they are in contact with him via text from their in car computer. He is stating that he is definitely on Kendallwood. I asked if he sees any business signs or any signs at all. He states that he can't. But he is sure he is on Kendallwood near a cross box. Trying to get a better location and possibly ping the cell phone.

3:34:49 **AT&T Amanda:** I know one of the cross-boxes is at 2601 Kendallwood.

3:35:27 **Gladstone Dispatcher #1:** Is he honking his horn? If he could just keep it going, if he could keep his hand on it, just lean on it if he has to.

3:35:37 **AT&T Amanda:** Have you gone toward the 2600 block too? That's where one cross-box is and the other one is right at that location. And still no response?

3:35:39 **Engine 2:** Engine 2, Do we have anything yet?

3:35:50 **Gladstone Dispatcher #2:** Patrol is still looking. They still haven't found anything. Sorry about that. We are on the line with AT&T trying to ping that cell phone.

3:36:06 **Gladstone Dispatcher #1:** Ok. You said 2800 block.

3:36:09 **AT&T Amanda:** 2601 is the location of the terminal. Let me pull it up on Google map and see if it is around anything.
